

Speakers' Biographies (in alphabetical order)

Mr Michael E ANDERSON

Supervisory Special Agent (Enron Task Force), Federal Bureau of Investigation, United States of America

Mr ANDERSON is Supervisory Special Agent of the Enron Task Force in Houston, Texas. After obtaining the Bachelor and Master of Business Administration degrees from the University of Louisville, Kentucky, Mr ANDERSON joined the FBI in 1989 and has primarily worked and supervised White Collar Crime violations, with particular concentration on economic crimes and corporate fraud. Prior to being assigned to Houston, Texas, Mr ANDERSON was a Supervisory Special Agent at FBI Headquarters in Washington, DC where he focused on economic crimes and international money laundering matters.

Mr Andrew C W BRANDLER

Vice-Chairman, Hong Kong General Chamber of Commerce Chief Executive Officer, CLP Holdings Limited

Mr BRANDLER is the Chief Executive Officer of CLP Holdings, the parent company of the CLP Group (formerly China Light and Power Company Limited), a position he assumed in May 2000. He is also a Vice-Chairman of Hong Kong General Chamber of Commerce.

Mr BRANDLER has had an extensive career as a banker in the energy and utility sector in North America, Europe and, since 1995, in Asia. His experience covers power sector deregulation in the United States during the 1980s, and, moving back to London in 1989, the UK electricity industry privatization and deregulation in the early 1990s. Immediately prior to joining CLP, Mr BRANDLER was Head of Asia-Pacific Corporate Finance at Schroders, the UK investment bank, based in Hong Kong.

Mr BRANDLER has an undergraduate degree from Cambridge University, an MBA degree from Harvard Business School, and is a member of the Institute of Chartered Accountants in England and Wales.

The Honourable Jerrold CRIPPS, QC

Commissioner, Independent Commission Against Corruption, New South Wales, Australia

The Honourable Jerrold CRIPPS, QC is the current Commissioner of the Independent Commission Against Corruption (ICAC). He is the fourth ICAC Commissioner and was appointed for a statutory five-year term in November 2004.

Mr CRIPPS has been a member of the judiciary for 15 years serving as Judge of the New South Wales Supreme Court and Court of Appeal, Chief Judge of the New South Wales Land and Environment Court, and Judge of the District Court of New South Wales.

Mr CRIPPS has served on a range of tribunals and committees including Chair of the Electoral Districts Commission, Chair of the National Electricity Tribunal, Chair of the Legal Aid Commission of New South Wales, and a member of the Court of Arbitration of Sport.

He has also been a member of the Judicial Commission of New South Wales, President of the New South Wales Anti-Discrimination Board, a parttime Commissioner of New South Wales Law Reform Commission and Chair of the Australian Commercial Dispute Centre.

Mr CRIPPS holds the degrees of Bachelor of Laws and Master of Laws from the University of Sydney. He was admitted to the Bar of New South Wales in 1959 and was appointed Queen's Counsel in 1974.

安德信先生是德克薩斯州休斯敦市安然專案小組的調查主任。安德信先生於肯塔 基州路易維爾大學取得工商管理學士及碩士學位後,於1989年加入聯邦調查 局,專責處理及監督有關白領罪行的案件,特別是經濟犯罪和企業詐騙案件。安 德信先生被派駐德克薩斯州休斯敦市前,是華盛頓市聯邦調查總局的調查主任, 專責處理有關經濟犯罪和跨國清洗黑錢的調查工作。



包立賢先生

香港總商會副主席 中電控股有限公司行政總裁

包立賢先生於2000年5月加入中電集團(前稱中華電力有限公司)母公司 – 中電控 股有限公司擔任行政總裁一職。他也是香港總商會副主席。

包立賢先生是資深銀行家,曾在北美、歐洲和自1995年起在亞洲等地的能源和 公共事業界工作,經驗豐富。他曾經歷八十年代美國開放電力市場,1989年返 回倫敦後,再體驗九十年代初英國電力業的改革和私有化。在加入中電前,他曾 任英國投資銀行施羅德亞太區公司財務駐港主管。

包立賢先生於劍橋大學取得學士學位,並持有哈佛商學院工商管理碩士學位;此 外,他亦是英國及威爾斯特許會計師公會會員。



高培思先生,QC 澳洲新南威爾斯廉政公署廉政專員

高培思先生是澳洲新南威爾斯廉政公署的現任專員。高培思先生於2004年11月 獲委任為第四任廉政專員,法定任期為五年。

高培思先生在司法界服務了15年,期間曾任新南威爾斯最高法院及上訴法庭法 官、新南威爾斯土地及環境法庭首席法官及新南威爾斯區域法院法官。

高培思先生亦曾於不同的審裁處及委員會擔任要職,包括選區事務委員會主席、 全國電力事務審裁處主席、新南威爾斯法律援助委員會主席、體育事務仲裁庭成 員等。

他亦曾是新南威爾斯司法委員會委員、新南威爾斯反歧視委員會主席、新南威爾 斯法律改革委員會的兼任會長,及澳洲商業糾紛中心主席。

高培思先生是悉尼大學法學士及法學碩士。他於1959年取得新南威爾斯的大律 師資格,並於1974年獲任命為御用大律師。

Ms Jane DIPLOCK, AO

Chairman, International Organization of Securities Commissions Chairman, New Zealand Securities Commission

Ms DIPLOCK took office as the Chairman of the Securities Commission in New Zealand on 3 September 2001. She was re-appointed in February 2006 for a further five-year term.

Previously Ms DIPLOCK was the National Director, Infrastructure and Strategic Planning, and New South Wales Regional Commissioner with the Australian Securities and Investments Commission. Ms DIPLOCK has held senior executive positions with Westpac Banking Corporation and was managing director of the New South Wales Technical and Further Education Commission.

Ms DIPLOCK was elected Chairman of the Executive Committee of the International Organization of

Securities Commissions in May 2004, a two-year post she holds concurrently with her chairmanship of the New Zealand Securities Commission. She is a member of the Trustee Appointments Advisory Group set up by the International Accounting Standards Committee Foundation.

Ms DIPLOCK was made an officer of the General Division of the Order of Australia on 26 January 2003 for "service to business and commerce, to public administration, particularly in the areas of education and training, and to the community through a range of social justice, health, educational and cultural organizations".

Mr James F DUFFY

Executive Vice President and General Counsel, New York Stock Exchange Regulation, United States of America

Mr DUFFY is an Executive Vice President and the General Counsel of NYSE Regulation, the regulatory arm of the New York Stock Exchange. Since joining the NYSE in 1999, Mr DUFFY has been extensively involved in both domestic and international listings matters, and market structure issues. Mr DUFFY was centrally involved in the formulation of the Exchange's expanded corporate governance listing standards, and in the changes to the Exchange's own governance structure as well. Previously, Mr DUFFY served for ten years as General Counsel of the American Stock Exchange. Earlier he practiced corporate and securities law on the legal staff of GTE Corporation, and with the firm of Lord, Day & Lord in New York. Mr DUFFY graduated from New York University School of Law, and has a BA in Anthropology from Fordham University.



狄珮珞女士, AO 國際證券事務監察委員會組織主席 新西蘭證券事務監察委員會主席

狄珮珞女士於2001年9月3日出任新西蘭證券事務監察委員會主席,2006年2月 獲委連任五年。

在此之前,狄珮珞女士曾任基建及策略規劃署的全國總監和澳洲證券及投資事務 委員會的新南威爾斯分區主席。狄珮珞女士在西太平洋銀行擔任過不同的高級行 政職位,亦曾是新南威爾斯工業及持續教育委員會的執行董事。

狄珮珞女士於2004年5月獲選出任國際證券事務監察委員會組織的執行委員會主 席,任期兩年,同時兼任新西蘭證券事務監察委員會主席一職。她現時也是國際 會計準則委員會基金會所成立的受託管理人委任事務諮詢小組的成員。

2003年1月26日, 狄珮珞女士獲頒澳洲一般類別官佐勳章, 以表揚她「對工商界 及公共行政事務所作出的貢獻,尤其是在教育及培訓範疇上,以及透過社會公 義、衛生、教育和文化組織對社會所作出的貢獻」。



杜羽飛先生 美國紐約證券交易所監管部執行副總裁兼總法律顧問

杜羽飛先生是紐約證券交易所監管部的執行副總裁兼總法律顧問。該公司是紐約 證券交易所的監管機構。杜羽飛先生自1999年加入紐約證券交易所後,一直積 極參與及處理本土和國際的上市事務,以及市場架構問題。杜羽飛先生在制定加 強公司管治的上市準則和改善紐約證券交易所本身的管治架構方面,亦扮演非常 重要的角色。

杜羽飛先生曾任美國證券交易所總法律顧問十年。在此之前,他是通用電話電子 國際公司和紐約Lord, Day & Lord律師事務所的執業律師,專責處理有關公司法 和證券法的事務。杜羽飛先生於紐約大學法學院畢業,同時是富爾敦大學人類學 學士。



Ms Helen GARLICK

Assistant Director, Serious Fraud Office, United Kingdom

Ms Garlick is a barrister and an Assistant Director at the Serious Fraud Office London (SFO).

The SFO is a multi-disciplinary department staffed with lawyers, accountants and financial investigators. It investigates and prosecutes the most serious and complex cases of fraud and corruption in the United Kingdom. It also assists foreign jurisdictions with their investigations. Among the cases she has worked on are the investigation by Italian authorities into alleged offences committed by the Italian Prime Minister Silvio Berlusconi and the Nigerian Attorney General's case against the family of the late General Sani Abacha.

Mr Robert HODGKINSON

Executive Director, Technical, The Institute of Chartered Accountants in England and Wales, United Kingdom

Mr HODGKINSON is Executive Director, Technical at the Institute of Chartered Accountants in England & Wales (ICAEW), the largest professional accountancy body in Europe with over 127,000 members. He joined the Institute in October 2002 from public practice.

Chairman, Hong Kong Institute of Directors Deputy and Vice Chairman, Ocean Grand Group of Companies

Mr HUI is Deputy and Vice Chairman of Ocean Grand Holdings Limited, one of the top five manufacturers of aluminium extrusion products in China and Deputy Chairman of Ocean Grand Chemicals Holdings Limited, the largest electroplating chemicals producer in China. Both companies are listed on the main board of the Stock Exchange of Hong Kong (SEHK). Mr HUI has a Bachelor of Laws degree from the University of Hong Kong. 


馬龍先生 美國通用電氣公司法律總監 - 亞太區

As an official and later as a consultant to governments he has acquired extensive experience in international fora, most notably as a member of the Financial Action Task Force on Money Laundering between 1989 and 1993, the Chemical Action Task Force on Precurser Chemicals, and in 1990 as Chairman of an Intergovernmental Expert Group of the United Nations to determine the extent of illicit trafficking in drugs.

He has been a consultant to corporations, international organizations and foreign governments on issues related to governance.

Mr Michael RAKE

Chairman, KPMG International

Mr RAKE is Chairman of KPMG International and Senior Partner of KPMG in the United Kingdom. Prior to his appointment as Chairman of KPMG International he was Chairman of KPMG in Europe.

The Honourable Mr Justice ROGERS, V-P, JP

Justice of Appeal, Court of Appeal of the High Court Former Chairman, Standing Committee on Company Law Reform, Hong Kong Special Administrative Region

Justice ROGERS was called to the Bar in England & Wales in November 1969 and practised as a barrister in London, before he moved to Hong Kong in 1976 to practise. Whilst a barrister his practice was larger patent, trade marks and copyright oriented. In 1984, he was appointed Queen's Counsel. From 1985 to 1990 he served as a Member in the Basic Law Consultative Committee. Between 1990 and 1992, he was Chairman of the Hong Kong Bar Association. In 1993, Justice ROGERS was appointed a judge of the High Court in Hong Kong and became a Companies Judge. In 1994, he was also appointed as Chairman of the Standing Committee on Company Law Reform. He retired from the Committee on completion of its then current work on corporate governance issues. In 1997, he was appointed Judge of the Court of Appeal and became the Vice-President in 2000.

Justice ROGERS is interested in rowing, golf and music, and is a director and the company secretary of the Hong Kong China Rowing Association.

The Honourable Madam Justice Nazhat SHAMEEM


Justice of High Court, Fiji

The Honourable Madam Justice Nazhat SHAMEEM is a judge of the High Court of Fiji. She is the former Director of Public Prosecutions of Fiji, and was a prosecutor for 16 years. In that capacity, she prosecuted many corruption and fraud trials, and was Director when the National Bank of Fiji collapsed. That collapse led to Reserve Bank investigations, police investigations, and criminal prosecutions. Justice SHAMEEM is a graduate of Sussex University and Cambridge University. She holds an LLM degree and a Master of Philosophy (Criminology) degree, both from Cambridge University. She is a barrister of the Inner Temple, London. She has been a judge since 1999, and currently sits in the criminal jurisdiction of the High Court.

Mr Paul SHAW

Senior Assistant Director, Commercial Prosecutions Branch, Commonwealth Director of Public Prosecutions, Sydney Office, Australia

Mr SHAW is a lawyer and is a Senior Assistant Director of the Commonwealth Director of Public Prosecutions (DPP) in Sydney, New South Wales, Australia. The Commonwealth DPP prosecutes Australian Federal offences, including offences under the Corporations Act. There have been several complex prosecutions in the NSW courts for such offences in the last few years, which have arisen from corporate collapses. Mr SHAW has over 15 years experience in prosecuting such matters and manages a team of lawyers undertaking that work in Sydney. He has also studied the methodology of the investigation and prosecution of similar matters in the UK and USA. Mr SHAW has accounting qualifications and a Master of Laws degree.

He was appointed as the Head of Corporate and Investment Banking on 1 February 2005, and then the Chief Operating Officer of Asia Pacific Investment Banking on 10 February 2006. Mr SLEVIN has over 20 years of experience in the financial services industry in London, New York and Hong Kong. He has held senior positions in banking in Hong Kong for over 12 years. Prior to joining Citigroup, he was the Vice-Chairman of the investment banking arm of BNP Paribas in Asia.

The Honorable Ronald J TENPAS

Associate Deputy Attorney General, Office of the Deputy Attorney General, Department of Justice, United States of America

Mr TENPAS has served as Associate Deputy Attorney General since November 2005. In that role he serves as a senior advisor to the Deputy Attorney General. This includes assisting both in formulating Department policy and in exercising operational oversight over a wide-range of Justice Department programs and initiatives. Among his specific duties are coordinating work of the President's Corporate Fraud Task Force, overseeing a variety of public corruption investigations involving public officials, and reviewing legislative proposals related to preventing and punishing misconduct by corporate and public officials.

Before becoming Associate Deputy Attorney General, he served for two years as the United States Attorney for the Southern District of Illinois pursuant to Presidential appointment and Senate confirmation. As the chief federal prosecutor in the district, Mr TENPAS directed the work of 35 federal prosecutors whose work included several significant corporate health care fraud prosecutions and the prosecution of multiple local government officials for corrupting elections and misusing their public offices. During his time as United States Attorney, Mr TENPAS also served on Attorney General Gonzales's first Attorney General's Advisory Committee of United States Attorneys (AGAC) and as Vice-Chair of the AGAC's Sentencing Subcommittee.

Mr TENPAS attended Michigan State University, from which he graduated with high honors in International Relations in 1985. He was awarded a Rhodes Scholarship to attend Oxford University where he studied Philosophy, Politics and Economics, receiving a degree in 1987. The Panel is independent of the Government and any special interest groups.
