如要在選舉廣告中使用某人/組織的名義支持候選人,必須事先獲得該人/組織的書面同意。該組織亦必須經過組織的管理層或於全體大會議決通過。

《選舉(舞弊及 非法行為)條例》

DISTRICT COUNCIL ELECTION

The Elections (Corrupt and Illegal Conduct) Ordinance ("ECICO"), enforced by the ICAC, aims to uphold clean and fair elections. As an elector of the newly established District Committees Constituencies in the upcoming District Council Election, you are reminded to familiarize yourself with the provisions of the ECICO so as to avoid any contravention due to inadvertence. Highlights of the requirements are as follows:

- Do obtain the written authorization from a candidate to be the candidate's election expense agent before incurring election expenses for the candidate.
- Do obtain prior written consent from a person or organization for including the support of the person or organization concerned in an election advertisement. Approval from the governing body of the organization or by a resolution of the members of the organization passed at a general meeting is required by the organization before giving the consent.
- Do not offer any advantage as an inducement to or a reward for any person's voting or not voting for a particular candidate at an election. Any person who solicits or accepts any advantage for the above purpose will also commit an offence under the ECICO.
- Do not offer any food, drink or entertainment as an inducement to or a reward for any person's voting or not voting for a particular candidate at an election. Any person who solicits or accepts any food, drink or entertainment for the above purpose will also commit an offence under the FCICO.
