Support Clean Elections



《選舉(舞弊及非法行為)條例》由廉政公署負責執行，旨在確保選舉廉潔公正。條例適用於選舉期間、之前或之後在香港境內及其他地方作出的一切與選舉有關的行為。違法者的最高刑罰是罰款50萬及監禁七年。

The Elections (Corrupt and Illegal Conduct) Ordinance (ECICO), enforced by the ICAC, aims to uphold clean and fair elections. It applies to all conduct concerning an election, whether the conduct is engaged in within Hong Kong or elsewhere before, during or after the election period. Any person who breaches the ECICO is liable to a maximum penalty of a fine of \$500,000 and imprisonment for 7 years.

It is an offence to publish any false or misleading statement of fact about a candidate for the purpose of promoting or prejudicing the election of the candidate.

如要在選舉廣告中使用組織的名義支持候選人，必須經過組織的管理層或於全體大會議決通過，否則即屬違法。

It is an offence to include the name of an organisation in an election advertisement claiming its support to a candidate, unless approval has been obtained from the governing body of the organisation or by a resolution of members of the organisation passed at a general meeting.
