ICAC Service Overview

The Independent Commission Against Corruption (ICAC) offers a full range of services free of charge, including integrity training, integrity promotion resources and advisory services, to help public bodies foster an ethical culture among their employees and members of the governing body.

Online and Offline Integrity Training



Face-to-face Training

Integrity training is provided to all levels of staff and members of public bodies and those whose work nature is more prone to corruption. The content is customised to address the needs of public bodies with real cases to illustrate the legal requirements and to cover topics such as handling conflict of interest, managing staff integrity, ethical leadership, etc.



Online Learning Course

Tailored for public bodies with concise content for self-learning purpose, facilitating staff of public bodies to receive integrity training conveniently. The course is uploaded onto the thematic website and could be linked to intranet of public bodies.



Corruption Prevention Advisory Services



Ready to provide sample codes of conduct for reference, and to assist public bodies in formulating and reviewing their codes of conduct for their employees and members.

Ready to provide advice on how to prevent corruption in public bodies, e.g. building in control measures in the business processes.

Diversified Educational and Publicity Materials

Serving as a one-stop portal for public bodies with diversified educational and publicity resources, such as online learning modules, videos and frequently asked questions.



Training Videos

Storyline based on real corruption cases, covering corruption-prone areas in different functions of public bodies. The videos are used for scenario discussion in ICAC talks. Some episodes are appended with explanation of legal requirements to facilitate in-house training by public bodies.



Animations

Interesting and informative short clips to illustrate the anti-corruption laws and related integrity themes, such as the meaning of public servant and corruption, and how to handle conflict of interest.
